According to the National Aging in Place Council, the majority of older Americans want to remain in their homes as long as possible, but often lack the awareness of home and community-based services that make independent living possible. This innovative training will focus on developing that awareness in social workers, case managers, counselors and other allied health providers, so they can in turn support clients in their personal journeys to “age in place.”. We will begin our day of learning with MaryLea Boatright-Quinn, LCSW, Alzheimer’s Association and current NAIPC President – Atlanta Chapter reviewing “Aging in Place 2019” – taking a look at advances, advocacy and creative programs across the country addressing aging in place needs. She will also review ethical standards from the social work, nursing, counselor and case manager codes which apply to some of the issues that can arise when our clients choose to age in place. Following this session, we’ll have Assistant Georgia State University Professor, Sarah Barber discussing negative stereotypes around aging and how these can actually lead to self-fulfilling prophecies with our clients. She will define these negative stereotypes and review best practice interventions– even around performing clinical assessments with our older clients. From here, we move to an interactive panel discussion on *Successful Aging in Place Panel: Different Perspectives* – including perspectives of technology assisted services and the older adults themselves. Finally, we will close out our day with a continued discussion on pertinent ethical dilemmas that can arise with our clients – including a focus on Balancing Safety and Risk with a panel of experts including an APS worker, hospital social worker and much more! 2. Identify 2 mechanisms that may be behind negative stereotypes of older adults & 2 possible interventions that may overcome these.
3. Name at least 2 resources or “best practice” interventions that may allow older adults to age-in-place more successfully.
4. Name 2 additional ethical dilemmas that can arise – especially focusing on how to balance autonomy vs safety (and define dignity of risk).
5. Consider an Ethical Framework in reviewing ethical dilemmas around Aging in Place.
