## Guidelines for Care Providers

The number of older adults in the United States is rapidly increasing as the baby boomer generation ages and lives decades longer than in previous generations. This generation is overwhelmingly opting to age-in-place, remaining connected to the communities in which they live. Research shows that removing older adults from those connections can result in isolation and depression. To provide quality care for the chronic and complex health conditions of older adults, as well as to foster and support a web of interdependence, our healthcare system will need to evolve in order to focus on an integrated and patient-centered approach to care. In this eye-opening presentation, Greg Eldridge will guide attendees through the effects that aging has on adults, the socioemotional and health impacts of those changes, and the integrated model of care that supports whole-person wellbeing for older adults.
